NEW BATTLE SHIP OKAYED

Atago, 10,000 Ton Cruiser, Made In Kure

TOKYO, Apr. 3—Atago, a new 10,000 ton cruiser was recently completed at Kure and commissioned into the Imperial navy with appropriate ceremonies Saturday.

It is the sixth of Japan's group of eight 10,000 ton cruisers, the 7th, the Maya, is now undergoing trials and is expected to be commissioned within 2 months.

All the ships carry ten 8 inch guns and have a top speed of about 33 knots.
